**1. Elections and Appointments**

**a. Election of Council Chair**

Fran Smith, Town Clerk, opened the organizational meeting and asked for nominations for Council Chair.

Councilor Desmarais nominated Councilor Lowe to be Council Chair for 2005.

**Councilor Galloupe moved, Councilor Sartoris seconded, to cease nominations for Council Chair. The motion carried with nine (9) yeas.**

**The Council voted nine (9) yeas to elect Councilor Lowe as the 2005 Brunswick Town Council Chair.**

Chair Lowe spoke on his vision for the Council in 2005. He felt that finances are going to be the order of the day for the first six months. With all the work that the Legislature is doing on tax reform, there will be an impact on Brunswick and the Council will need to make priorities based on the town's needs. The second half of the year, he sees the Council making a decision on what to do with the old high school.

**b. Election of Council Vice Chair**

Chair Lowe asked for nominations for Vice Chair.

Councilor Desmarais nominated Councilor Galloupe as Council Vice Chair for 2005.

Hearing no other nominations, Chair Lowe called for a vote of the Council.

**The Council voted nine (9) yeas to elect Councilor Galloupe as the 2005 Brunswick Town Council Vice Chair.**

**c. The Town Council will appoint the Town Attorney.**

**Chair Lowe moved, Councilor Galloupe seconded, to appoint the firm of Bernstein, Shur, Sawyer and Nelson as the Town Attorney. The motion carried with nine (9) yeas.**

**d. The Town Council will appoint Council Representatives to the following:**

- i. Appointment Sub-Committee – 3 councilors [previously Desmarais, Galloupe and Rice]**

Chair Lowe, without objection of the Council, appointed Councilor Tucker, Councilor Sartoris and Councilor King to serve on the Appointments Sub-Committee.

**iv. Cable Television Committee [previously Priest]**

Chair Lowe, without objection of the Council, appointed Councilor Ansari to serve on the Cable Television Committee.

**v. Growstown School Committee [Councilor from District 3, Galloupe]**

Chair Lowe, without objection of the Council, appointed Councilor Galloupe, as the Councilor from District 3, to serve on the Growstown School Committee.

**vi. Recycling Committee [previously King]**

Chair Lowe, without objection of the Council, appointed Councilor Ansari to serve on the Recycling Committee.

**vii. Trust Investment Advisory Committee [previously McCausland]**

Chair Lowe, without objection of the Council, appointed Councilor Galloupe to serve on the Trust Investment Advisory Committee.

**viii. Mid-Coast Business Development and Planning – 5 councilors [previously Watson, Galloupe, Priest, Sartoris, and King]**

Chair Lowe, without objection of the Council, appointed Councilor Watson, Councilor Galloupe, Councilor Sartoris, Councilor King and Councilor Desmarais to serve on Mid-Coast Business Development and Planning.

**ix. Times Record Committee (new)**

Chair Lowe, without objection of the Council, appointed Councilor Galloupe, Councilor Tucker, and Councilor Sartoris to serve on the Time Record Committee.

**x. Union Negotiating Committee**
