Overview of the Methodology

Leisure Vision conducted a Parks and Recreation Needs Assessment Survey Fall of 2013 to help establish priorities for the future development of an outdoor Aquatic Center within the town of Brunswick Maine. The survey was designed to obtain statistically valid results from households throughout the town of Brunswick. The survey was administered by mail and by phone.

Leisure Vision worked extensively with Brunswick Maine officials in the development of the survey questionnaire. This work allowed the survey to be tailored to issues of strategic importance to effectively plan the outdoor aquatic facility.

A six-page survey was mailed to a random sample of 1500 households within the town of Brunswick Parks and Recreation boundaries. Approximately three days after the surveys were mailed each household that received a survey also received an automated voice message encouraging them to complete the survey. In addition, about two weeks after the surveys were mailed Leisure Vision began contacting households by phone. Those who had indicated they had not returned the survey were given the option of completing it by phone.

The goal was to obtain a total of at least 300 completed surveys. ETC/Leisure Vision reached that goal with a total of 313 surveys completed. The results of the random sample of 313 households have a 95% level of confidence with a precision rate of at least +/-5%. The return rate was 21%.

The following pages summarize major survey findings.

Current Usage of Coffin Pond:

Of surveyed respondents, (27%) have used Coffin Pond for swimming purposes over the past 12 months. Seventy-six percent (76%) of those respondents used the Pond between 1 and 10 days and only (24%) have used the Coffin Pond 11 or more days. Of respondents (who use Coffin Pond for swimming), almost half, (40%) rate the overall condition as either “fair” or “poor.”

- ❖ **Respondent Usage of Coffin Pond for Swimming:** Twenty-seven percent (27%) of respondents have used Coffin Pond for swimming over the past 12 months. Of those (27%) of respondents who used Coffin Pond for Swimming over the past 12 months; (58%) used the pond 1-5 days, (18%) used the pond 6-10 days, (15%) used the pond 11-25 days, (6%) used the pond 26-50 days and (3%) used Coffin Pond 100+ days.
- ❖ **Respondent Rating of the Overall Condition of Coffin Pond:** Forty-six percent (46%) rate the overall condition of Coffin Pond as “good.” Other respondent ratings of the overall condition of Coffin Pond include: “Fair” (29%), “poor” (11%), “excellent” (10%) and “not provided” (5%).
- ❖ **Facilities at the Coffin Pond Area that Respondent Households Have Used and How Respondents Rate the Overall Condition of Those Facilities:** Of the (27%) of respondents who use Coffin Pond, twenty-one percent (21%) of respondents use the *Sandy Beach*. Other facilities respondents who use Coffin Pond use include: Waterslide (21%), playground area (20%) and restrooms with changing facilities (18%). Of respondents who use these facilities, (48%) of respondents rate the overall condition of the facilities at Coffin Pond they have used as “good.” Other respondent’s ratings include: “Fair” (46%), “excellent” (2%) and “poor” (4%).

Potential Development of an Outdoor Aquatic Center:

- ❖ **Potential Outdoor Aquatic Features Respondents Would Use:** Sixty-one percent (61%) of respondents would use *lap lanes for exercise, lessons and lap swimming* if developed at an outdoor aquatic center. Other outdoor aquatic features that respondent households would use if developed include: A lazy river (60%), a leisure pool with gentle slope entry for walking (59%), concession area (57%) and water slides (55%).
- ❖ **Potential Aquatic Features Respondent Households Would Use Most Often:** Based on the sum of respondent top three choices (from most important to third most important), (39%) of respondents would use *lap lanes for exercise, lessons and lap swimming*. Other outdoor aquatic features respondents would use the most often include: A lazy river (36%), a leisure pool with gentle slope entry for walking (34%) and water slides (33%).

- ❖ **Primary Reasons Why Respondents Would Use an Outdoor Aquatic Center in the Town of Brunswick:** Seventy-six percent (76%) of respondents would use an outdoor aquatic center in the Town of Brunswick for *recreational swimming purposes*. Other reasons why respondents would use an outdoor aquatic center in the Town of Brunswick include: Exercise (61%), instructional classes (36%), sunbathing (24%) and therapeutic purposes (20%).

- ❖ **If a New Aquatic Center was Developed, How Often Would Respondent Households Use the Center Each Season?** Eighteen percent (18%) of respondents would use the aquatic center 1-5 days per season. Other levels of respondent usage include: 6-10 days (13%), 11-25 days (31%), 26-50 days (15%), 51-100 days (12%) and “don’t know” (12%).

- ❖ **Maximum Amount of Money Respondents Would Pay for:**
 - **A Family Season Pass to the Aquatic Center:** Sixty-six percent (66%) of respondents are willing to pay \$105 or more for a family season pass compared only (34%) of respondents who are willing to pay “nothing” for a family season pass to the Aquatic Center. Other rates respondents are willing to pay for a family pass to the outdoor aquatic center include: \$105-\$119 (24%), \$120-\$134 (17%), \$150 or more (15%) and \$135-\$149 (10%).

 - **A Seasonal Youth Pass to the Aquatic Center:** Sixty-four percent (64%) of respondents are willing to pay \$30 or more for a seasonal youth pass compared to only (36%) of respondents are willing to pay “nothing” for a seasonal youth pass to the Aquatic Center. Other rates respondents are willing to pay for a seasonal youth pass to the outdoor aquatic center include: \$30-\$39 per season (24%), \$40-\$49 per season (18%), \$50-\$59 per season (14%) and \$60 or more (8%).

 - **A Seasonal Adult Pass to the Aquatic Center:** Seventy percent (70%) of respondents are willing to pay \$40 or more for a seasonal adult pass compared to only (30%) of respondents are willing to pay “nothing” for a seasonal adult pass to the Aquatic Center. Other rates respondents are willing to pay for a seasonal adult pass to the outdoor aquatic center include: \$40-\$49 per person (26%), \$50-\$59 per person (20%), \$60-\$69 per person (14%) and \$70 or more per person (10%).

 - **A Daily Youth Fee to the Aquatic Center:** Sixty-seven percent (67%) of respondents are willing to pay \$3.50 per day or more for a daily youth fee compared to only (33%) of respondents are willing to pay “nothing” for a daily youth fee to the Aquatic Center. Other rates respondents are willing to pay for a daily youth fee to the Aquatic Center include: \$5.00 per day (27%), \$3.50 per day (21%), \$4.00 per day (18%) and \$4.50 per day (1%).

- **A Daily Adult Fee to the Aquatic Center:** *Seventy-two percent (72%) of respondents are willing to pay \$4.00 per day or more for a daily adult fee compared to only (25%) who are willing to pay “nothing.” Twenty-eight percent (28%) of respondents are willing to pay \$5.00 per day for a daily adult fee to the aquatic center. Other rates respondents are willing to pay for a daily adult fee includes: “nothing” (25%), \$4.00 per day (22%), \$7.00 per day (16%) and \$6.00 per day (9%).*
- ❖ **Facilities Respondents Would Like to See Surrounding the New Aquatic Center:** *Sixty-eight percent (68%) of respondents would like to see picnic areas surrounding the new Aquatic Center. Other facilities respondents would like to see surrounding the new Aquatic Center include: Playground area (60%), walking trails (57%), and the sandy beach (51%).*

Potential Location of an Outdoor Aquatic Center:

- ❖ **Locations Respondents Would Support for Developing a New Aquatic Center:** *Seventy-seven percent (77%) of respondents would support Brunswick Landing for the location to develop the new Aquatic Center. Other locations respondents would support for the development of the new Aquatic Center include: On 15 acres between the navy house and route 24 (43%) and elsewhere on the Coffin Pond parcel (42%).*

Funding for Improvements to Outdoor Aquatics Program Spaces:

- ❖ **Respondent Feeling Toward the Cost of Operating a New Aquatic Center:** *Thirty-eight percent (38%) of respondents state that the majority of the cost of operating a new Aquatic Center should come from fees from users. Other respondents opinion toward the cost of operating the Aquatic Center include: 100% through fees (26%), majority through taxes (20%), “don’t know” (13%), and 100% through taxes (4%).*
- ❖ **Respondent Willingness for a Property Tax Increase to Fund the New Outdoor Aquatic Center Project (per \$100,000 of assessed value):** *Twenty-four percent (24%) of respondents would be willing to pay an additional \$4.00 property tax increase to fund the new outdoor Aquatic Center project. Other property tax increases respondents are willing to pay to help fund the new outdoor Aquatic Center include: \$8.00 (22%), \$12.00 (10%), \$16.00 (9%) and “nothing” (35%).*
- ❖ **Respondent Priority Rating for a the Town of Brunswick to Develop a New Outdoor Aquatic Center:** *Thirty-two percent (32%) of respondents give a medium priority rating for the Town of Brunswick to develop a new outdoor Aquatic Center. Other priority ratings include: A high priority (22%), not a priority (20%), a low priority (18%), and do not have an opinion (8%).*

- ❖ **Primary Reasons Respondents Feel it is a “High” or “Medium Priority” for the Town of Brunswick to Develop a New Outdoor Aquatic Center:** Forty-seven percent (47%) of respondents state that *Coffin Pond is not an adequate facility* as primary reason for their rating of “high” or “medium” priority for the Town of Brunswick to develop a new outdoor Aquatic Center. Other primary reasons respondents placed the Town of Brunswick to develop a new outdoor Aquatic Center include: We need more outdoor aquatic programming areas (44%), other (8%) and don’t know (1%).
- ❖ **Primary Reasons Respondents Feel it is a Low, Not a Priority or Have no Opinion:** Fifty-two percent (52%) of respondents place developing a new Aquatic Center at a low priority, not a priority or have no opinion because they *will not pay a tax increase*. Other reasons for respondents ratings include: Other (31%), Coffin Pond is an adequate facility (13%) and don’t know (4%).
- ❖ **Level of Importance Respondents Place on Having an Outdoor Public Swimming Pool in the Town of Brunswick:** *Sixty-eight percent (68%) of respondents feel that it is “important” to develop an outdoor public swimming pool in the Town of Brunswick compared to only (21%) who felt it was “not important.”* Thirty-seven percent (37%) of respondents feel that having an outdoor public swimming pool in the Town of Brunswick is “somewhat important” and (31%) feel that it “very important.” Other levels of importance respondents place on having an outdoor public swimming pool in the Town of Brunswick includes: Not important (21%), not sure (10%) and not provided (1%).

Projected usage of the Aquatic Center compared to current usage of Coffin Pond:

If an outdoor Aquatic Center is developed respondents would use the Aquatic Center more often than current usage rates of Coffin Pond. Seventy-six percent (76%) of respondents used Coffin Pond between 1-10 days over the past 12 months and only (24%) used the Coffin Pond 11 or more days. With respondents projected use of the Aquatic Center (58%) would use the new outdoor Aquatic Center 11 or more days per season.

Priority for the development of an outdoor Aquatic Center:

Over half of the respondents, fifty-four percent (54%) place the development of an outdoor Aquatic Center at a “medium” or “high priority.” Of those (54%), forty-seven percent (47%) of respondents place the Aquatic Center at a “high” or “medium priority” because they state that the Coffin Pond is NOT an adequate facility. Only thirteen percent (13%) of respondents who placed the development of a new outdoor Aquatic Facility as a “low priority” or “not a priority” see Coffin Pond as an adequate facility.

Funding the new outdoor Aquatic Center:

Sixty-five percent (65%) of respondents are willing to pay an additional tax increase to fund the new outdoor Aquatic Center. Of those (65%) who are willing to pay an additional tax increase to fund the Aquatic Center, (100%) would be willing to pay \$4.00 or more toward the project. Sixty-three percent (63%) of those respondents would be willing to pay a property tax increase of \$8.00 or more. Thirty percent (30%) of respondents would be willing to pay a property tax increase of \$12.00 or more and (14%) of respondents are willing to pay a property tax increase of up to \$16.00 to fund the Aquatic Center project.

User Fees to the Aquatic Center:

Family Season Pass: Currently residents are paying \$60.00 for a family season pass to Coffin Pond. Based on resident responses from the survey instrument, (66%) of respondents would be willing to pay \$105 or more, (42%) of respondents would be willing to pay \$120 or more for a family season pass to the Aquatic Center.

Seasonal Youth Pass: Residents currently pay \$20 for a seasonal youth pass to Coffin Pond. Based on resident responses from the survey instrument, (64%) of respondents are willing to pay \$30 or more, (40%) of respondents are willing to pay \$40 or more for a seasonal youth pass to the Aquatic Center.

Seasonal Adult Pass: Residents currently pay \$30 for an individual seasonal adult pass to Coffin Pond. Based on resident responses from the survey instrument, (70%) of respondents are willing to pay \$40 or more, (50%) of respondents are willing to pay \$50 or more for a seasonal adult pass to the Aquatic Center.


Daily Youth Fee: Currently residents pay \$2.50 for a daily youth fee to Coffin Pond. Based on resident responses from the survey instrument, (67%) of respondents are willing to pay \$3.50 or more, (46%) are willing to pay \$4.00 or more for a daily youth fee to the Aquatic Center.

Daily Adult Fee: Residents are currently paying \$3.50 for a daily adult fee to Coffin Pond. Based on responses from the survey instrument, (72%) of residents are willing to pay \$4.00 per day or more, (50%) of respondents are willing to pay \$5.00 or more for a daily adult fee to the Aquatic Center.

Q1. Over the Past 12 Months, Have You or any Members of Your Household Used Coffin Pond for Swimming?



Q1. Over the Past 12 Months, Have You or any Members of Your Household Used Coffin Pond for Swimming?


by percentage of respondents (who have used Coffin Pond)

Q3. Respondent Rating of the Overall Condition of Coffin Pond



Q4. Facilities at the Coffin Pond Area that Respondent Households Have Used


by percentage of respondents who use Coffin Pond (multiple choices could be made)

Q5. How Respondent Households Rate the Overall Quality of All the Facilities They Have Used at Coffin Pond



Q6. Respondents Would Use the Following Potential Features if Developed at an Outdoor Aquatic Center


by percentage of respondents (multiple choices could be made)

Q7. Potential Aquatic Features that Respondent Households Would Use the Most Often


by percentage of respondents (based on top three choices)

Q8. Primary Reasons Why Respondents Would Use an Outdoor Aquatic Center in the Town of Brunswick


by percentage of respondents (based on three primary reasons)

Q9. If a New Aquatic Center was Developed, How Often Would Respondent Households Use the Center Each Season?






by percentage of respondents



Q10d. Maximum Amount of Money Respondents Would Pay for a Daily Youth Pass to the Aquatic Center?








Q13. Respondent Feeling Toward the Cost for Operating a NEW Aquatic Center



Q14. Respondent Willingness for Property Tax Increase to Fund the New Outdoor Aquatic Center Project


by percentage of respondents (per \$100,000 of assessed value)

Q15. What Priority Should the Development of a NEW Outdoor Aquatic Center be in the Town of Brunswick?



Q15a. Respondents PRIMARY Reasons for Placing the Development of a New Outdoor Aquatic Center at a High or Medium Priority





Q16. Level of Importance Respondents Place on Having an Outdoor Public Swimming Pool in the Town of Brunswick


by percentage of respondents

Q17. Demographics: Ages of People in Household


by percentage of respondents

Q18. Demographics: Age of Respondents


by percentage of respondents

Q19. Demographics: Gender of Respondents


by percentage of respondents

Q20. Demographics: How Many Years Have You Lived in the Brunswick Area?



Q21. Demographics: Household Income


by percentage of respondents


