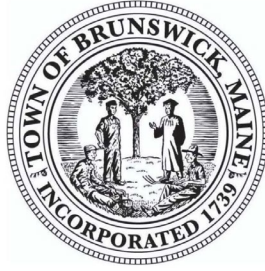

The **Brunswick Planning Board** will hold a remote and in-person **PUBLIC HEARING** on Thursday, **January 26th, 2023** at 6:30 P.M. in Town Council Chambers at 85 Union Street to discuss the following:

1. **Appeal of Case No. 22-043 – 36 & 42 Eastern Shore Rd. – Paul’s Marina:** The Zoning Board of Appeals will hold a **PUBLIC HEARING** in accordance with Section 5.2.7.A of the Brunswick Zoning Ordinance; to consider the request of Drummond Woodsum, on behalf of Seth Holbrook, owner of 53 Gallows Island Road, to appeal the decision taken by the Brunswick Planning Board on October 11, 2022 regarding the development review approval of the replacement and expansion of a marine bulkhead, the subject property is located at 36 Eastern Shore Rd. (Map MP3, Lot 19) with a construction easement on 42 Eastern Shore Rd. (Map MP3 Lot 21) within the **Rural Protection 1 (RP1) Zoning District, Rural Protection Management Stormwater Overlay (RPSMO) District,** and the **Shoreland Protection Overlay (SPO) District.**
