1. 2023 Field Projects & Schedule (Devereaux):
 - Quahog nursery project, as discussed at the October 5, 2022 meeting, with Brian Beal of the Downeast Institute, is postponed while they wait for a schedule. This will be a harvester paid project. More information forthcoming.
 - Spat recruitment project with Brian will move forward in Harvest Bay and Thomas Point Beach.
 - Quahog project with Marissa McMhann of Manomet off Rocky Point is moving forward. This project was discussed at the October 5, 2022 meeting.
 - Staff has put down the Towns LPA at the boat launch and will be bringing them back up in April and floating them and taking them out before Memorial Day. Dates and times forthcoming.
 - 2023-2024 Shellfish Surveys to be discussed under Item 3 on the agenda.
