Dear Mooring Owner,

This is the annual registration reminder to all Brunswick mooring owners. Please submit your annual mooring renewals to the Brunswick Town Clerk's Office, 85 Union Street by May 1st to avoid any late fee charges. Please use the attached renewal form. All forms must be complete and provide accurate information.

- **Mooring Registrations.** Your mooring number must be painted in 4 inch block letters on the side of your mooring ball. Please be sure that the vessel registered to the mooring is the vessel that occupies the mooring throughout the season. If you have a transient vessel on your mooring for any length of time please notify the Harbormasters Office. **IT IS ILLEGAL TO RENT PRIVATE MOORINGS**, without distinct approval from the US Army Corp of Engineers.

-**Registration Fees.** Resident (a real estate tax payer) \$50.00 Non Resident \$100.00. If you do not intend to install your mooring please contact the Harbormaster's office. Once your registration has been received you will receive a 2019 registration sticker that is to be affixed to the top of your mooring ball.


- **Inspections.** All mooring holders will be required to inspect their moorings every other year. Mooring owners must affirm that an inspection has been completed.

RE: MPBL Boat Launching Size Restrictions

Mere Point Boat Launch Users,

Happy New Year. Before you know the 2019 boating season will be upon us. I'm writing to inform you of rules that will be enforced at the Mere Point Boat Launch by the Maine Department of Inland Fisheries and Wildlife and the Town of Brunswick for the upcoming boating season.

Over the past several years the Mere Point facility has become an increasingly popular site for boaters. The acquisition and construction of the launch was the result of many years of work and significant public input into its design and management. In response to public input the launch, parking areas and traffic flow were specifically designed to accommodate boats of 24 feet or less. Launching boats greater than 24 feet can result in damage to the facility and interfere with the safe flow of traffic in the facility. Beginning immediately, any launching or hauling of vessels that exceed 24 feet in length will be strictly prohibited.
