Spend the week with Seaspray Kayaking having fun on the water at Kayaking and Paddleboarding Camp! With every day being outside and on the water, it is the perfect camp for this summer!! We will be modifying activities to coincide with the CDC Recommendations, but participants will still learn the proper paddling skills and safety will be taught to ensure plenty of summer fun after the camp.

Each participant will have their own kayak and/or paddleboard as they explore the New Meadows River standing up and sitting down and all participants will be using the same kayak and paddleboard each day with all equipment being cleaned daily by the participants and then by the staff each day.
