This year Summer Vacation Camp is changing to *Summer Vacation Care*. This change is due to the current COVID-19 Pandemic and it will result in many of our traditional camp features being different than those of years past. COVID-19 has also changed the way the program will be delivered as we will be adhering to the reopening guidelines established by the State of Maine’s Department of Economic & Community Development (DECD) regarding operation of Day Camps and Summer Recreation. In preparation for the 2020 season, staff has consulted with local health officials & Maine CDC in order to help lower the risk of program participants and staff contracting COVID- 19. This program is designed as a day care option with the intent to provide fun and safe activities for those families that need a summer child care option. The 7 week program registration requirement is to ensure that children will remain with the same cohort group of children throughout the entire summer to reduce COVID-19 risk. In order to meet the DECD requirements and to lower the risk to the greatest extent possible of children and staff being exposed to COVID-19 the cost of the program has increased to allow for higher staff ratios, cleaning & sanitization supplies, protective gear, Camp Health Officer, & increased equipment and supplies.

**Notable changes from last year’s Vacation Camp  
Due to COVID-19 Pandemic**

- Bus Trips will not be permitted which will prevent us from traveling for swimming, state and local parks & amusement parks
- Activities will be limited to those that maintain 6ft spacing ( masks are required for periods of time that 6ft distance cannot be maintained)
- Summer Vacation Care will be restricted to only 42 children per school site.
- Each camp will be separated in to smaller groups of 14 or less with 2 counselors per cohort group and will spend the majority of time with this smaller group throughout the program.
- There will be up to 3 different school sites where the program may operate depending on enrollment demand. Stowe School will be the only site providing both before and after care services, BJHS and potentially BHS will operate without a before and after care option.

**Measures designed to lower COVID-19 risk**

- Curbside In car drop off & pickup
- Daily temperature checks at drop off
- Daily morning health screening questions
- Day Care Camp Health Officer on staff
- Smaller cohort groups of program participants to reduce contact interactions
- Scheduled cleaning of equipment and restroom facilities throughout the day
- Greater staff to child ratio (1 staff to 6)
- Additional hand washing stations & charting
- Hand sanitizer/sunscreen provided
- Programming focus on non-contact activities
- Face coverings will be provided for times when 6 foot social distancing is not possible.
- Designated areas & tubs for personal items
