Program Session

Each session will consist of 4 regular season nights and 1 night of playoffs

League Details

- There can be a maximum of 12 teams and a Minimum 6 teams competing in the league.
- Game start times are 6pm and 7pm and there is a 15 min time limit per game.
- There must be a minimum of 8 adults per roster (teams must be gender diverse)
- Teams will compete 5v5.
- Game nights will consist of a best of 3 game series and there will be Double Headers for a total of 6 games to be played each night
- Games are played until all players for the opposing team are eliminated or time limit of 15 minutes has been reached
- Standings will be kept and each session will conclude with a 1-day playoff to determine a champion.

League Rules

- Players must be 18 years of age and out of High School
 - The Facility and parking lot are Alcohol, tobacco, vaping and drug free zones
 - This is a recreational league for the average adult, violence or aggressive competition behavior will not be tolerated
 - Teams are encouraged to attend the post play social over at Flight Deck Brewery where League Members will receive special discounts!
